20/145 To receive any Apologies for Absence and to approve the reasons given John Snell and Stephen Bartlett had sent their apologies.

20/146 Declarations of interests. None

20/147 To approve and sign as a correct record the minutes of the previous meeting **RESOLVED:** The minutes were approved as a true and accurate record of the meeting held.

20/148 Public Open Session to include County and District Councillors reports

Earlier that day, the clerk had received details of a proposed development within Mudford, for 250 properties. The company 'Grassroots' were advising the parish council that they were holding a public consultation until the 18th April 2021, details of which were available via the website link www.lva-mudfordroad.co.uk. After much discussion it was agreed that not enough time had been given for the parish council to provide a response or promulgate to residents of the parish. It was decided for the clerk to contact Grassroots to ask for a longer period of public consultation and for a small leaflet drop to be carried out targeting those properties most affected. County Councillor Mike Lewis gave a report providing a further breakdown of the council tax increases, with a large sum being provided for Adult Social Care and Citizens Advice Somerset to help with health issues brought about by Covid restrictions. Councillor Capozzoli joined the meeting at this point and reported that SSDC had just voted unanimously to grant a payment of £23 mil to the Octagon Theatre to help with its recovery and hopefully secure its future.

20/156 Parish Matters - Report on fibre broadband for Mudford

Councillors Lanigan, Sargent and the clerk had attended a M/S Teams meeting with the Director of Wessex Internet earlier that week and reported that there was a plan to roll out Fibre To The Premises (FTTP) throughout the parish of Mudford to all properties that had been identified as not having a 30Mb download speed currently. Landowners permission was being sought for cable routes and they hoped to have the parish connected within 24 months. A coverage postcode checker would be available mid-April 2021 via the website www.wessexinternet.com and anyone wishing to investigate further should contact them to discuss their package options.

20/157 Highways and Rights of Way Reports – Progress on issues raised with Somerset County Highways within Mudford Parish

A response had been received detailing the situation with each point that Councillor Rowlands had raised to County Highways. Councillor Sargent had arranged a meeting with County Highways to progress projects discussed prior to Covid and would report back at a future meeting. Councillor Lewis had been trying to progress the opening of the Hinton Bridge footpath and was in correspondence with the Rights of Way team. Councillor Sargent further reported that he was now able to start Speedwatch and was looking to start in the next couple of weeks. Currently 9 volunteers had come forward for training.
